# Important Notice Regarding Temporary Monitoring and Alarm Devices for Space only Stands

## Dear Exhibitors,

In accordance with the regulations set forth by the public security department, aimed at ensuring the safety and security of all participants at MWC Shanghai 2024, all **space only stands** must:

- install temporary monitoring with the aim to avoid blind spots and accurate equipment retrieval demands; and
- be equipped with a one-click alarm visual intercom device to provide quick response to emergencies and smart security construction (second-level response and multi-level linkage)
- **1. Fee Structure:** To comply with the requirements, exhibitors must adhere to the following fee structure:
  - **Temporary monitoring**: Rent 100 yuan/unit/exhibition period, deposit 200 yuan/set/exhibition period;
  - **One-click alarm visual intercom device**: Rent 300 yuan/unit/exhibition period, deposit 300 yuan/set/exhibition period.

\* Failure to complete installation and debugging before the exhibition, fines will be deducted from the Damage Deposit, and GSMA retains the right to suspend exhibition stand operations.


2. Rental/Deposit Payment: Exhibitors can make rental and deposit payments through Rental Mini Program on WeChat. The Mini Program QR code will be available on first week of June.

After entering the mini program, select the corresponding exhibition, find the stand where you need to rent equipment, click the confirm button after selection (support multiple selections of stands), add to cart, and submit the order on the shopping cart page. On the order confirmation page, check the order information for accuracy, fill in the contact person and contact phone number, click "Submit Order," choose a payment method, and proceed with payment.

### 3. Configuration Requirements

- **3.1. Temporary monitoring configuration requirements**: optimal installation height is 2.5 meters, monitoring range without blind spots:
  - Space only stands of 18 square meters and below: 1 set;
  - Space only stands of 19-72 square meters: 2 sets (diagonal installation or installation at both ends of the board wall);
  - Space only stands of 73-108 square meters: 3 sets (installation at three corners);
  - Space only stands of 109 square meters and above: 4 sets (installation at four corners).

\* For other special circumstances, based on the actual on-site situation, confirm the temporary monitoring plan for the stand.



#### 3.2. One-click alarm visual intercom device configuration requirements:

- Space only stands: 1 set/200sqm
- Shell Scheme stands: 1set/4stands (36Sqm)



## 4. Equipment Collection and Installation

During the exhibition, the contracting company will collect the equipment from the designated service point: Safety Devices Rental Services Station, Loading Bay #2 (in-between Hall W1and Hall W2), 2345 Longyang Road, Pudong New Area Shanghai, and install it within respective stands according to the configuration plan. Please ensure a valid power supply is available for continuous operation of the temporary monitoring and one-click alarm visual intercom device.

#### 5. Equipment Return

Upon dismantling, exhibitors are responsible for returning the equipment to the designated service point. Upon confirmation of return (please present order details), the deposit will be refunded in the original payment method. Any damaged or lost equipment will incur costs deducted from the deposit. The refund status of the deposit can be checked in "My Orders - Refunded."

#### 6. Invoicing

In the Mini Program – "My - Invoice Information", fill in the invoice information. When placing an order, if an invoice is required, select the filled-in invoice information. The finance department will review the invoice information within three (3) working days and send the electronic invoice to the email provided in the invoice information. Additionally, when returning the equipment on-site, you can also scan the QR code and fill in the invoice information.
